Clamping down on Rogue Traders - Trading Standards Prosecutions

Hertfordshire Trading Standards instituted legal proceedings against a paving contractor illegally trading under the names "Marshalls Driveways" and "Marshalls Drives". Marshalls provided a witness statement and the individual received a 6 months prison sentence, suspended for 2 years, and 120 hours community service. He was also ordered to pay costs of £1,500 to Trading Standards.

Marshalls provided an expert witness statement to assist Solihull Metropolitan Borough Council in their investigation of a surfacing contractor from Hampton-In-Arden. This rogue trader has been sentenced to eight months in prison after pleading guilty to offences of false trade descriptions, deception and failing to provide cancellation notices. He was also fined £5,000 and ordered to pay £4,630 compensation.

Ethical Trade Initiative (ETI)

No child labour used in quarrying Marshalls' natural stone products









To ensure we are fully able to act on this commitment in December 2005 Marshalls plc became a member of the Ethical Trade Initiative (ETI). The ETI is a unique organisation that brings global companies, trade union organisations and NGOs together to work out the solutions to ethical trade issues and then implement them. Members commit to adopting the ETI Base Code on a progressive basis throughout their supply chains. The Code is based on ILO (International Labour Organisation) conventions and, as such, is widely acknowledged as a model code of labour practice. It contains provisions based on the following principles:

ETI Base Code:

- Employment is freely chosen
- Freedom of association and the right to collective bargaining are
- Working conditions are safe and hygienic
- Child labour shall not be used
- Living wages are paid
- Working hours are not excessive
- No discrimination is practised
- Regular employment is provided No harsh or inhumane treatment is allowed
- As well as adopting the ETI Base Code, members also commit to:
- Monitoring and independent verification of their supply chains
- Reporting annually to ETI on their progress
- Awareness-raising and training
- Driving year-on-year improvements
- Assessing the impact of their core business activities on labour
- Participating in ETI projects

Marshalls has employed independent organisations such as SGS, the world's leading inspection, verification, testing and certification company, to audit our main Chinese Granite supplier and AQSR to audit our sole Indian Sandstone supplier for their compliance with

ETI Base Code. Both have now achieved full compliance.

Marshalls believe it is our duty to be able to demonstrate the highest ethical standards. We will continue to undertake regular screening and auditing to ensure that the highest standards are maintained at

Changes to the Construction **Industry Scheme**

(New CIS)

From 6 April 2007 the current scheme is due to be replaced by new CIS. The CIS tax scheme only applies to those Register members that work on a sub-contract basis for Marshalls (and/or any other main contractor) and does not affect all Register members. (Please note, CIS is not part of the Marshalls Register membership criteria.)

- There will no longer be any need for CIS cards, certificates or vouchers.
- Marshalls must check or 'verify' new subcontractors with HM Revenue and Customs.
- Subcontractors will still be paid either net or gross, depending on their own circumstances, but it will be HM Revenue and Customs who tell the contractor which treatment to use during verification, not a piece of plastic.
- There will also be a higher rate tax deduction if a subcontractor cannot be 'matched' on our system. This rate will apply until the subcontractor contacts HMRC and registers or sorts out any matching problem. Contractors will have to submit a return each
- The vast majority of subcontractors registered under the existing CIS rules will be transferred over to the new system and will not have to re-register.
- · New subcontractors, and those that formerly held only temporary registration cards that expired before new CIS starts, will be

Important information re Payments:

The information required from the subcontractors to verify their status will be either their NI number or UTR (Unique Taxpayer Reference) - If Marshalls cannot verify there status from the IR then they can still be paid, but tax will be deducted at 30% hence they need to insure that the NI or UTR number given to Marshalls is correct.
