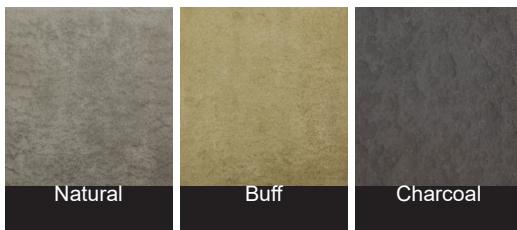


Urbex Riven 600 x 600 x 38
